

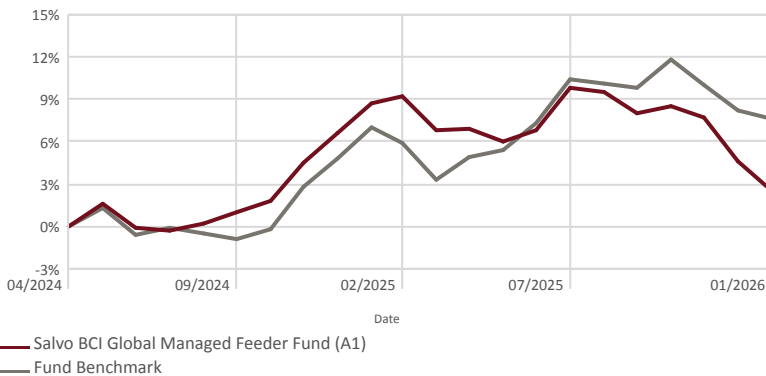
INVESTMENT OBJECTIVE

INVESTMENT POLICY

The portfolio invests, apart from assets in liquid form, solely in the participatory interests of the Salvo Global Managed Fund PC, established under the SA Alpha PCC Limited, domiciled in Guernsey. The underlying portfolio invest across asset classes and other portfolios in order to obtain its objective. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions and limits as stipulated by the Act.

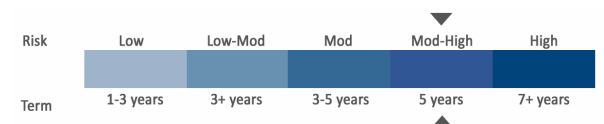

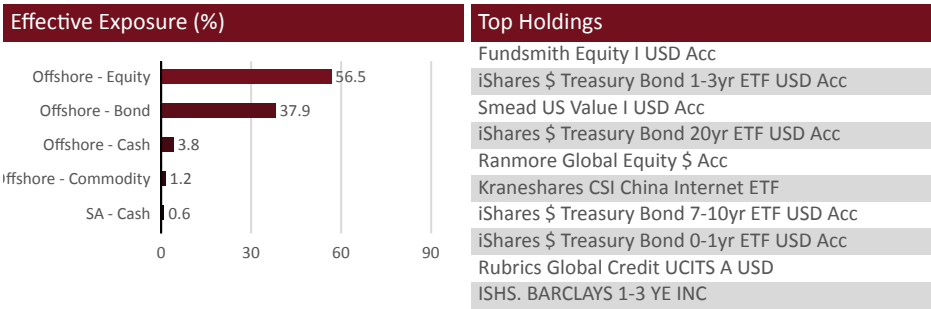
RISK PROFILE



Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a medium risk portfolio, but less than a high-risk portfolio. The probability of losses is higher than that of a medium risk portfolio, but less than a high-risk portfolio and the expected potential long-term investment returns could therefore be higher than a medium risk portfolio.
